## Pretrial Services Assessment Report

Prosecutors may now access the Pretrial Services Assessment Report (PSA) in CourtNet. The PSA report has also been updated to include a Current Bond information section. The report may be accessed using the Pretrial Report in the search results on the blue banner or by using the Pretrial Report action.

To be eligible to access reports, prosecutors must complete Pretrial Services Assessment Training provided by Pretrial Services. Training inquiries may be sent to: [PretrialReportsaccess@kycourts.net](mailto:PretrialReportsaccess@kycourts.net).

Prosecutors will no longer have access to the Pretrial Interview Application in KYeCourts as the information is now accessible in CourtNet.



3. Search for desired case by case number or party/business.






## Pretrial Report Action
